Personal data collected through these websites is processed in accordance with the General Data Protection Regulation (GDPR). By means of this Privacy Statement, Denetax Fiscalisten wants to inform you about the processing of your personal data via our Website.

### **What data do we collect?**

In principle, Denetax Fiscalisten does not collect personal data, unless you provide it to us by e-mail to our office.

### **What is the personal data collected on Denetax Fiscalisten used for?**

The personal data we collect through our Website is only used for the purposes for which it was provided. For example, we will only use your personal data to contact you, answer questions or make the requested documents available.

**How long will my personal data be kept?**

When you receive your personal data via e-mail, we will keep it for as long as necessary for the performance of the service or for as long as we have a service relationship with you. After this service relationship has ended, your personal data will be retained in identifiable form for a maximum of seven years.

**Is my personal data secured?**

Denetax Fiscalisten attaches great importance to your privacy. We therefore take security measures to prevent theft, loss or otherwise unlawful use of your personal data. Among other things, we use secure connections and, where necessary, encrypted communication. We also take measures with regard to physical and logical access security.

**Will my personal data be disclosed to third parties?**

Denetax Fiscalisten will never sell your personal data to third parties. Denetax Fiscalisten will also not disclose your personal data to third parties, unless we are legally obliged to do so, for example, on the basis of a legitimate claim from competent authorities and except when we use processors or third-party service providers.

**Where can I submit a request to view, correct or delete my personal data?**

You can submit a request to inspect the personal data collected about you by Denetax Fiscalisten via its Website(s) by sending an e-mail to [info@denetax.nl](mailto:info@denetax.nl). To verify your identity, Denetax Fiscalisten will ask you to send a copy of your ID. Make sure to black out your passport photo and citizen service number. In response to this request for inspection, you can ask Denetax Fiscalisten to adjust or delete your personal data.

**Complaint about processing your personal data**

If you have a complaint about the processing of your personal data, please let us know. If we are unable to reach a solution, you have the right to submit a complaint to the privacy supervisory body, the Dutch Data Protection Authority.
